- A. Annual Awards Banquet updates

- B. Grunions Give Back (see next page for ideas that were submitted)

- 1. After an engaged discussion regarding ideas submitted the board decided to focus on community engagement and supporting our volunteer coaches. The board agreed to devote \$10,000 of our current funds to these projects.
- 2. Kim Onisko moved that we allocate \$3750 to the following projects: \$3,000 to waterproof our youth/Los Altos YMCA (to be supported with additional funds from Aquatic Capital of America); \$1250 to fund two scholarships for the Long Beach Junior Guards Program (cost of program of \$1110 and \$140 for required swim wear); and \$500.00 to support Long Beach Poly and Jordan Highschool Girls Aquatics in the form of training suits and other gear needed by swimmers who are eligible for free and reduced lunch. Sam Antu seconded the motion. Approved unanimously.
- 3. Liz Carlin moved that we allocate \$2000 to supporting our volunteer coaches. Each active coach (8) to receive a \$250.00 check at the annual banquet. James Nelson seconded the motion. Motion approved unanimously (Ken Brisbin, Kim Onisko, and Michael Dirlam recused themselves from the vote because of their status as coaches).
  - a. Jim will have checks prepared and cards will be available at the banquet for swimmers to sign.
- 4. Laura to follow up with LBJG Program, LB Poly and Jordan High School, and with Queer Scouts United on a possible collaboration on free swimming lessons for queer foster youth.

## Grunions Give Back - Ideas for Giving Back to the Community/Team

- Support Los Altos Family YMCA Learn to Swim program/Aquatic Capital Waterproof our Youth
- The Center Long Beach possible volunteer opportunity
- Queer Scouts (big projects this past year included putting together essential items for queer foster youth transitioning out of the foster care system and Valentines for Queer elders).
- Pay for Grunion Coaches to register to swim at all swim meets. Reimburse coach after he or she attends and swims at meet.
- Pay a swim instructor to teach adult swim lessons and rent pool space on a regular basis for a few sessions per week one month each year. Grunion volunteers would be encouraged to help. This would support ALTS in April or any additional month.
- Offer scholarship to pay for pool lifeguard training in local areas to help combat lifeguard shortages.
- Donate to sponsor one or more LB Junior Guards scholarship (\$555.00 per student for 2024)
- Support LB Poly Girls Aquatics by providing targeted equipment funds for swimmers/water polo players in need.
- Grunion team suits and caps for new dues paying members.
- Paying for dues paying Grunions food at social venue
